His enrolment as an attorney of the Allahabad High Court Bar followed the completion of his postgraduate degree in 1919.

In the years that followed, Katju rose to prominence in Indian politics. Having served on the All-India Congress Committee and the Council of Uttar Pradesh Congress Committee, he was a devoted Congress Party member. Afterwards, he served in a number of capacities, including those of Allahabad Municipal Board Chairman, Minister of Justice, Industries and Development (UP), and Minister of Law, Justice, and Parliamentary Affairs for the United Provinces.²

Katju participated in scholarly and journalistic pursuits alongside his political posts. The National Herald and other publications were produced by Associated Journals Limited, of which he was a founding member. On the executive council of Banaras Hindu University, he was also a member.

Following the start of WWII, he actively sought jail time for his role in passive resistance. After his release in 1943, he went back to practicing law. After a further four years, he returned to the Pant Cabinet. He subsequently took office as governor of West Bengal and Orissa. In his capacity as minister of home, law, and state affairs, he travelled to New Delhi. Additionally, he was in charge of the defence portfolio for a while. From that point on, he was tasked with overseeing Madhya Pradesh as its chief minister for a while. He retired from this position and went back to Allahabad to live out his days quietly. It was in February 1968 when he passed away.

Although he had strong beliefs, Dr. Katju was an open-minded individual. For the helpless and oppressed, he felt profound compassion. The Allahabad Bar may have counted him among its leaders.

In search of employment opportunities in an Indian state, Kailash Nath Katju made his way back to Jaora. In the year 1908, he began practicing law in Kanpur. Before moving to Allahabad in 1914, he waited six years. Initially, he was not prejudiced against politics because of his prominence in the legal field. He became politically involved and took on the U.P. Pant Ministry's Law and Justice position.³

1.3. Legal Career and Achievements

India lost a highly esteemed legal genius in Dr. Kailash Nath Katju. He began his legal career after finishing law school and quickly gained renown for his incisive mind and commitment to fairness. This guy succeeded Sardar Patel and Rajaji as Union Home Minister, served as a member of the Constituent Assembly, was governor of Orissa and West Bengal, and then became the minister of defence. His credentials were impeccable. His tenure as chief minister of Madhya Pradesh was 1957–1962. His performance in each of these roles was commendable. Administrator, statesman, liberation warrior, lawyer as far as the top rankers are concerned, Katju is safe. A lot of people have worked hard to make India a free nation. The work of Dr. K. N.
